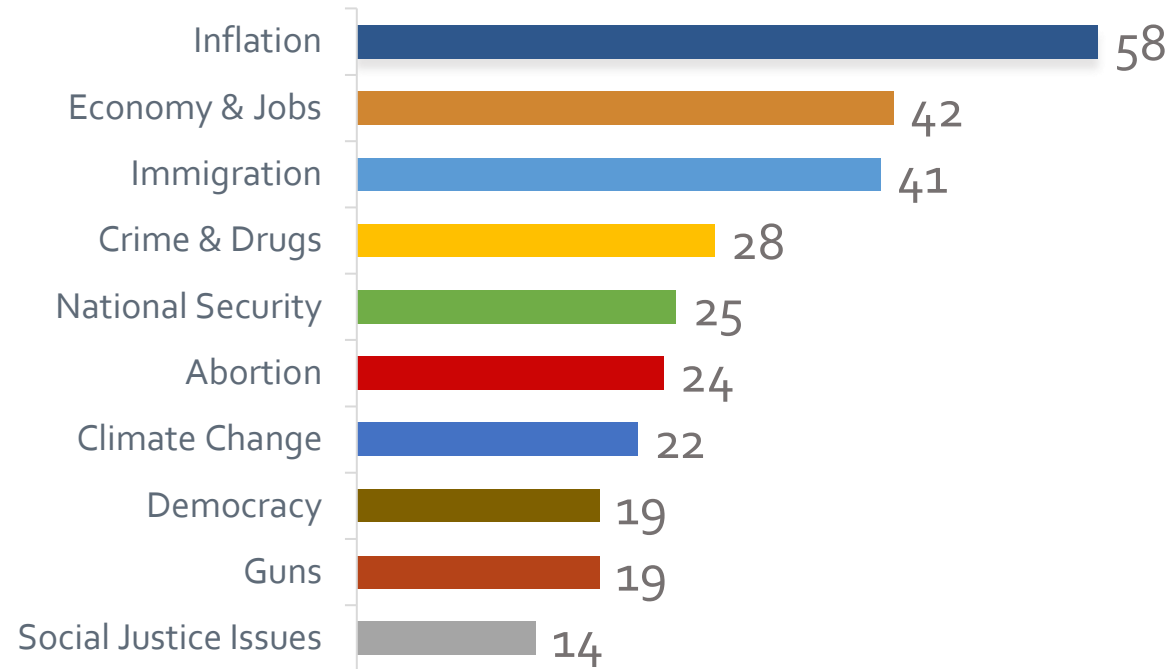

Do you think President Biden is a strong Commander-in-Chief of the United States that is protecting our national security?

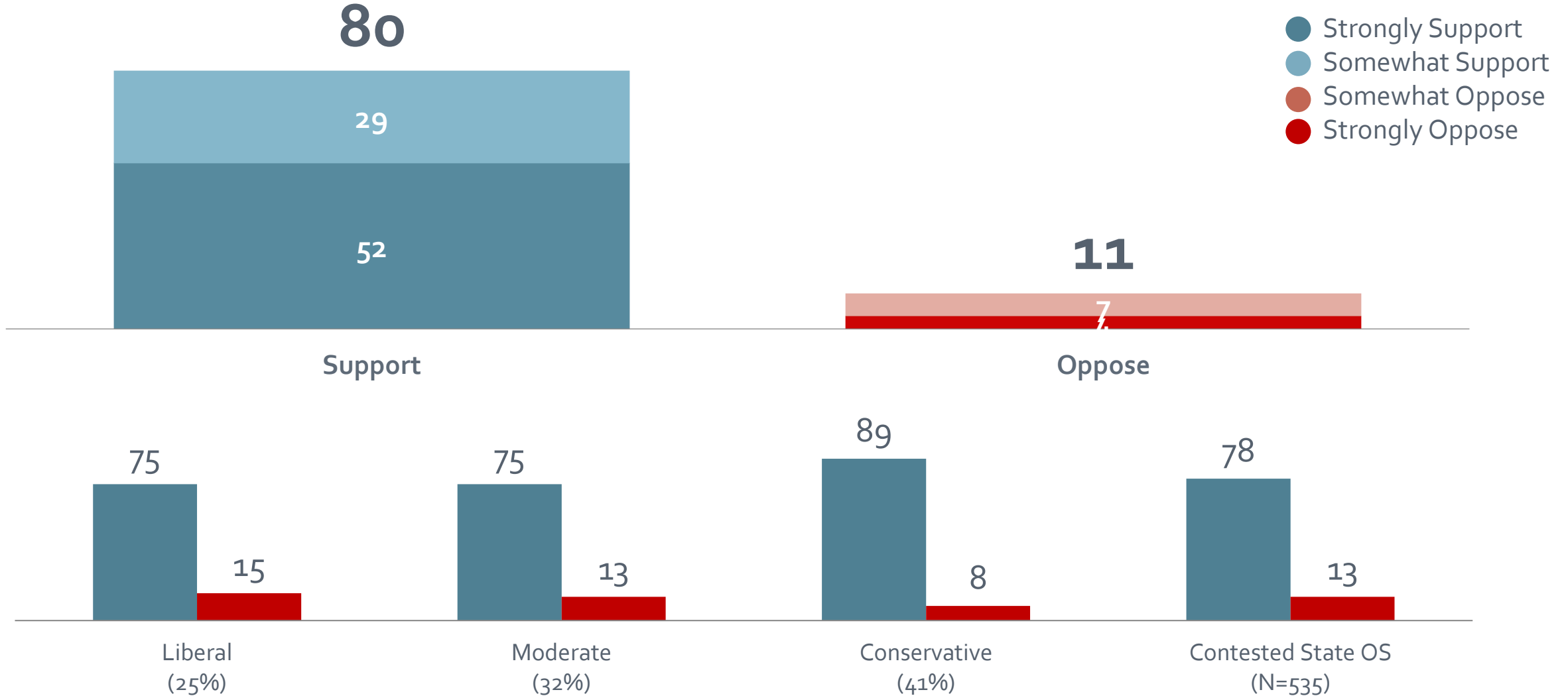

Do you support or oppose Congress investigating the Secret Service to discover how an assassination attempt was possible and hold those involved with presidential security accountable?

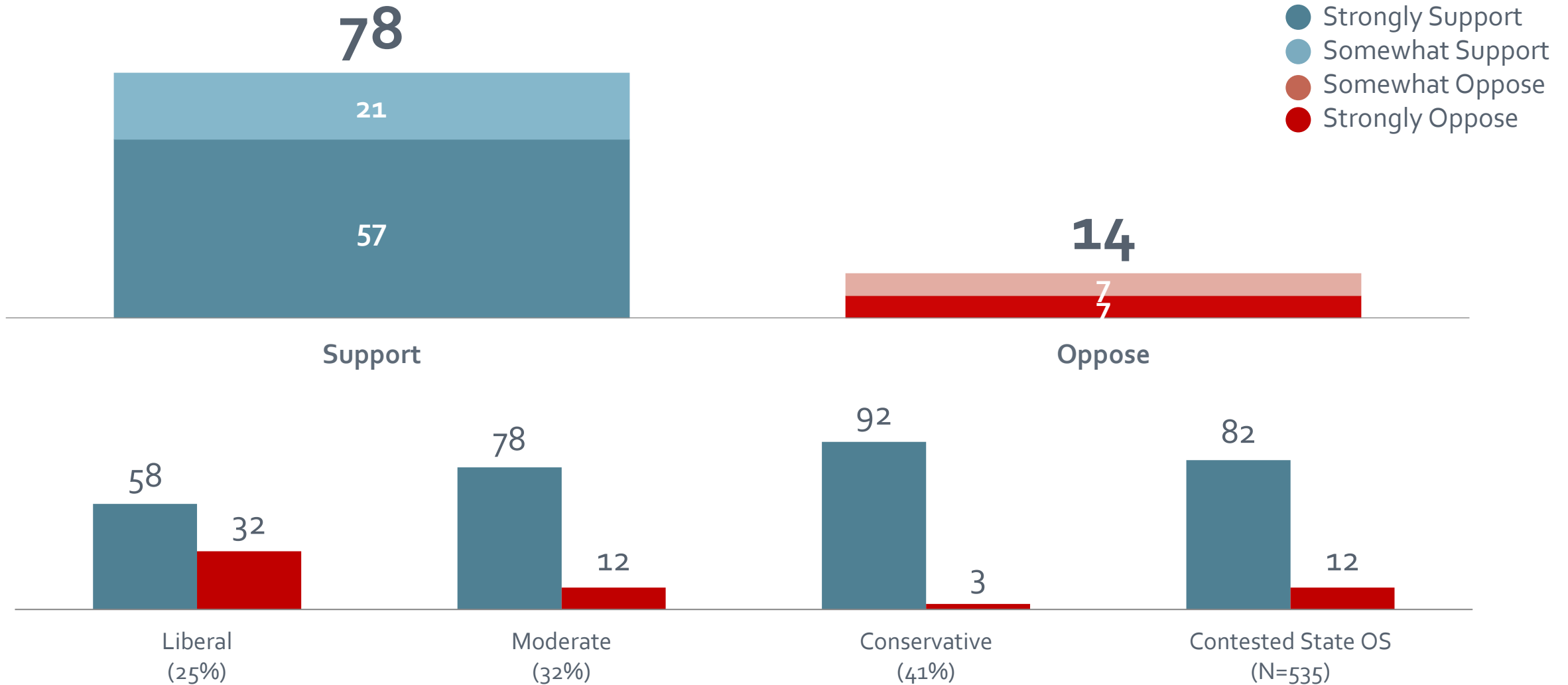




SAVE ACT

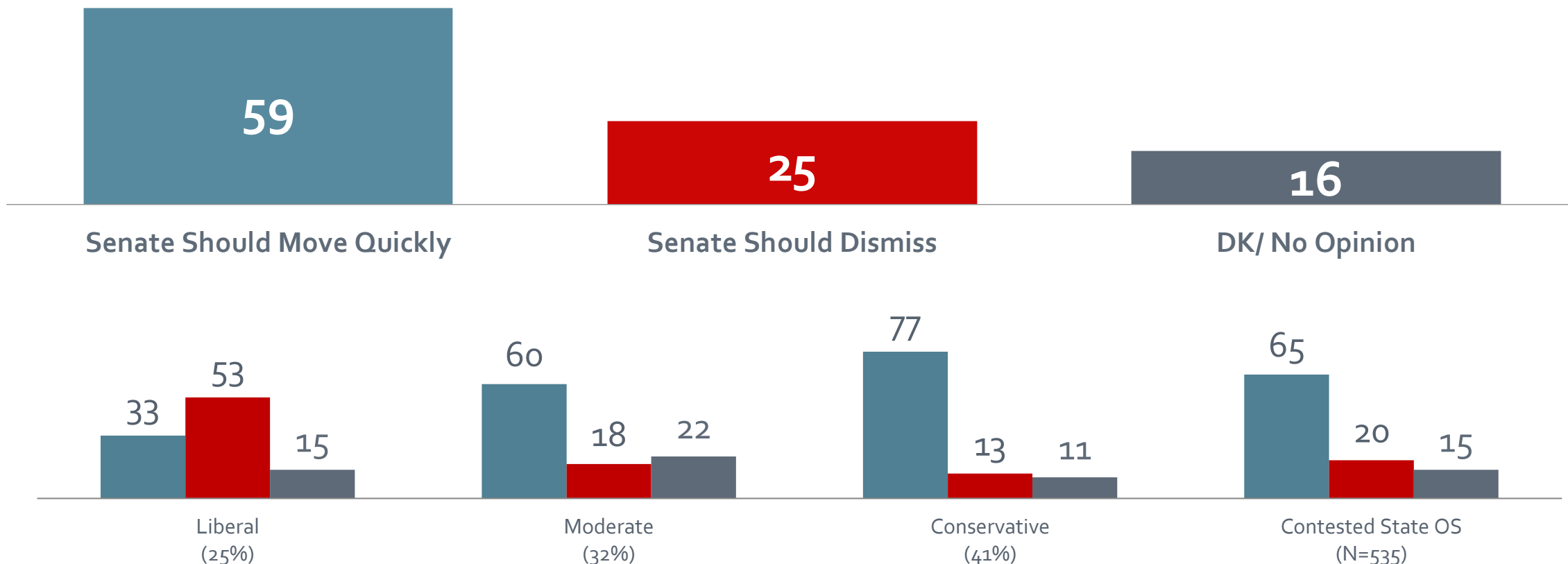


The SAVE act is now set to come before the U.S. Senate.

Some say the Senate should quickly vote to pass this bill to strengthen our voting laws and protections going into an election year.

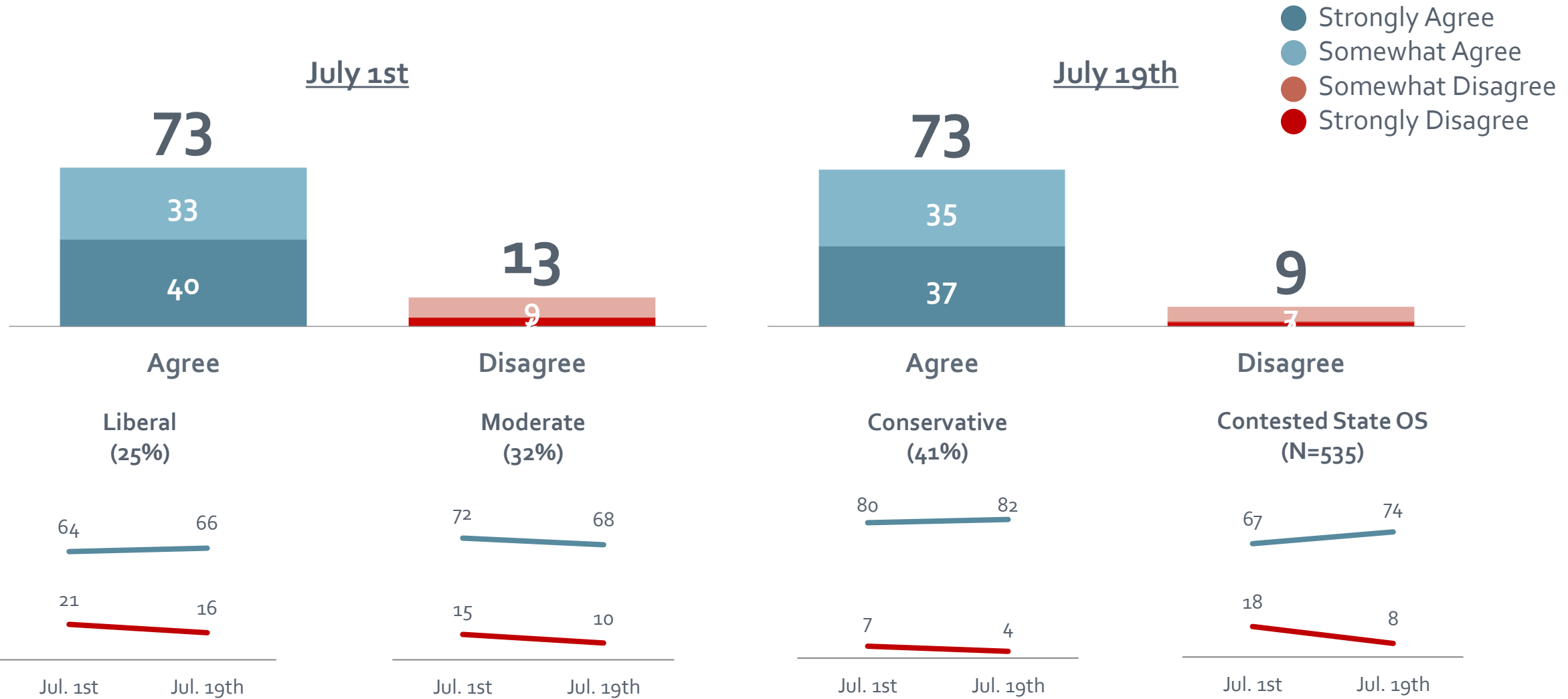
Others say that the Senate should dismiss this bill because it only makes it harder for people to register to vote and participate in our democracy.

 The U.S. Senate should immediately take up this year's NDAA to strengthen America's Armed Forces.

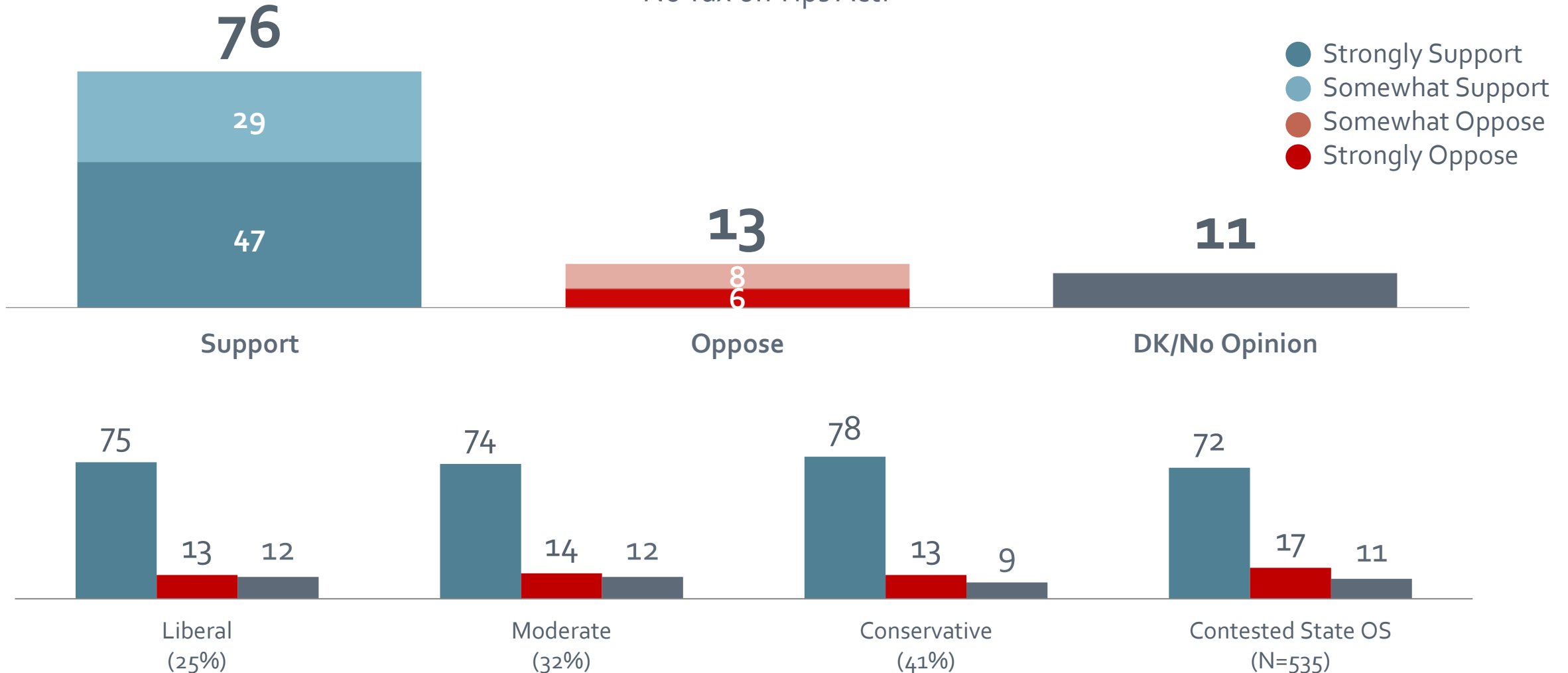




NO TAX ON TIPS ACT

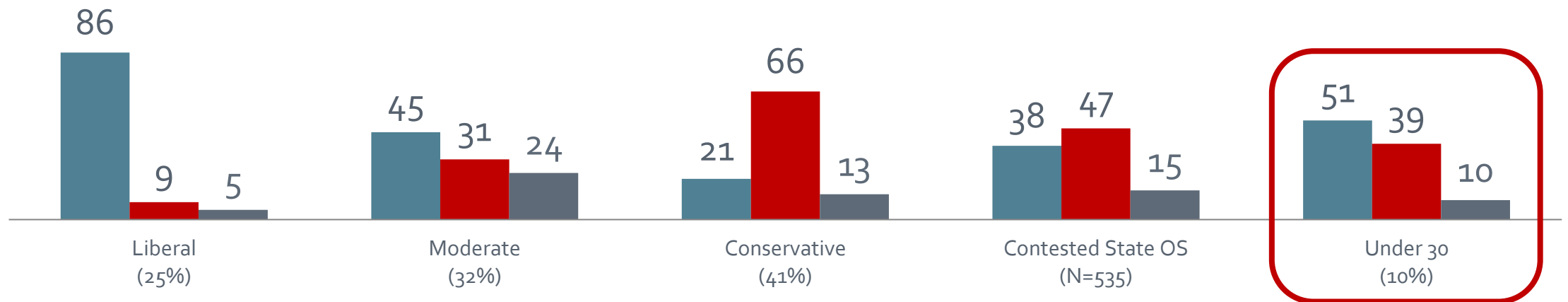

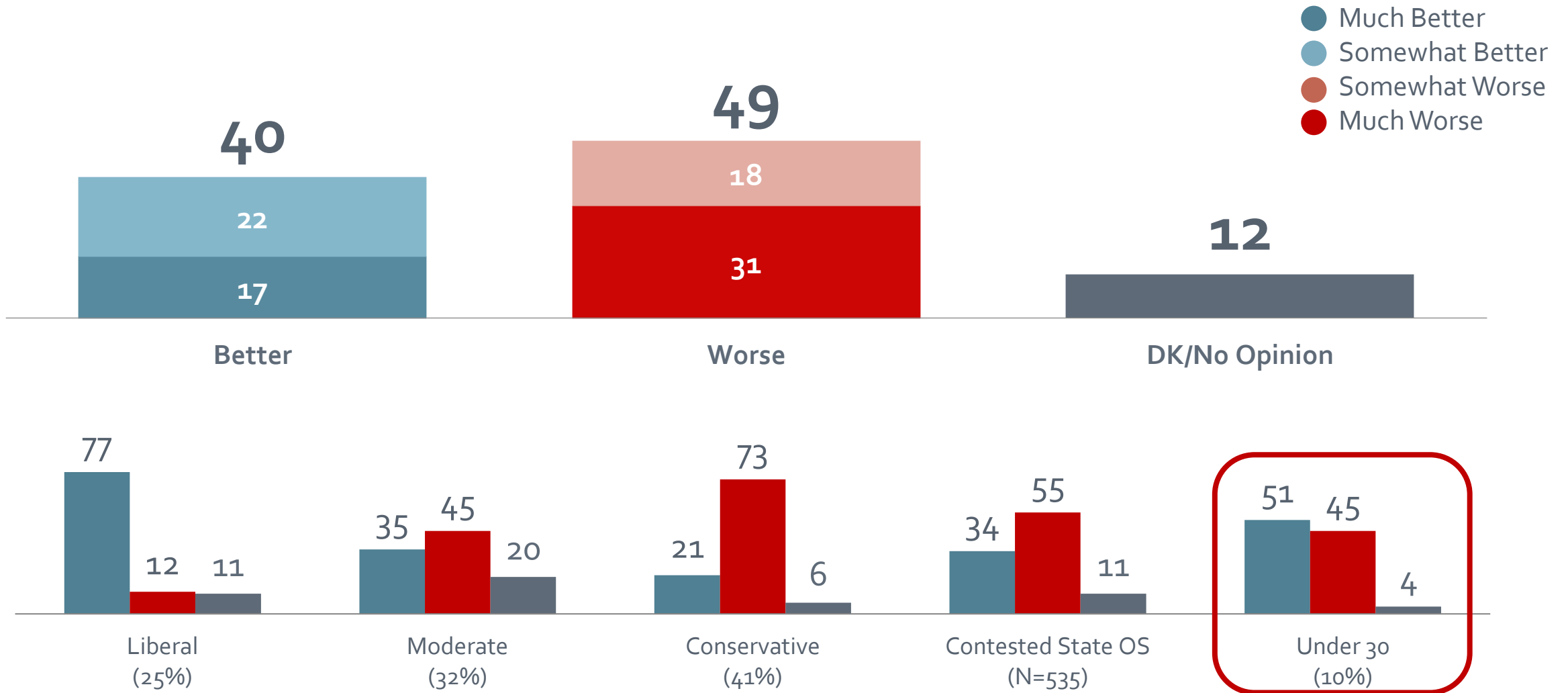

Which party do you believe better represents the interests of young Americans?



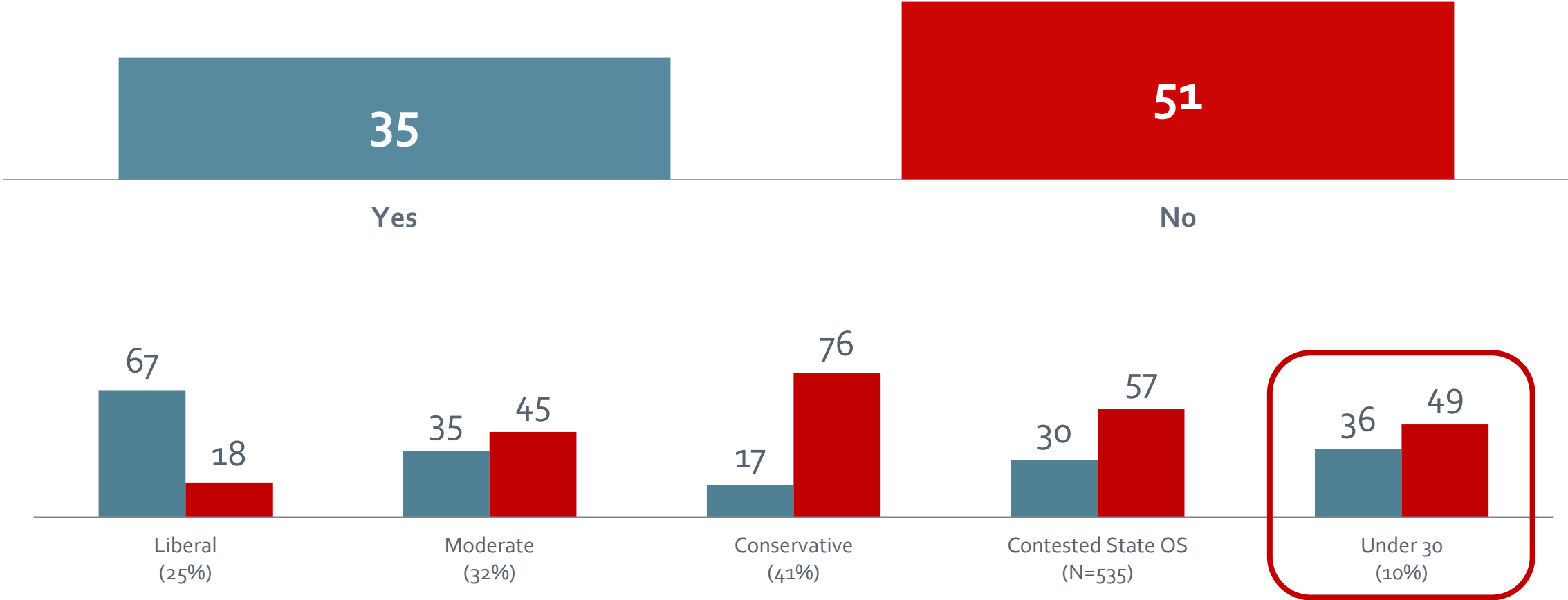
BIDEN IMPACT ON YOUNG AMERICANS

Do you believe the majority of young people in America are doing better or worse under the Biden Administration?



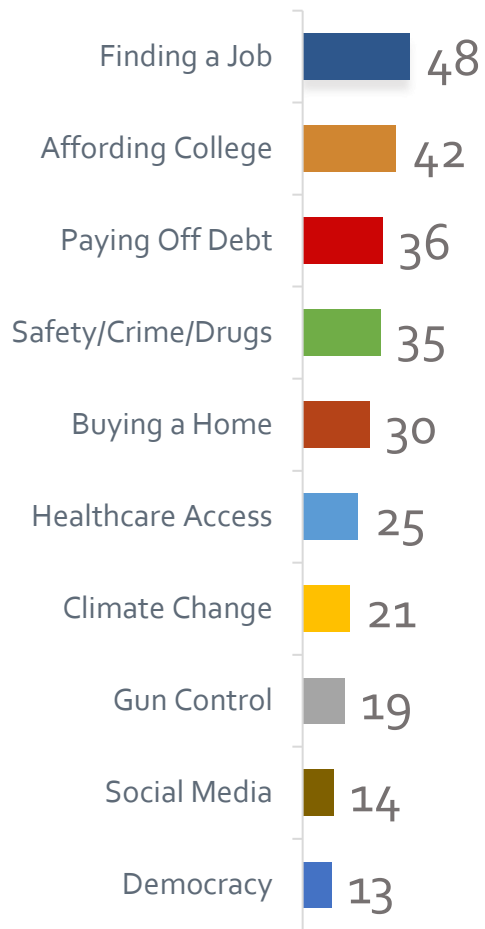
HAS BIDEN KEPT PROMISES?

Do you believe that President Biden has been able to keep his promises to young Americans?

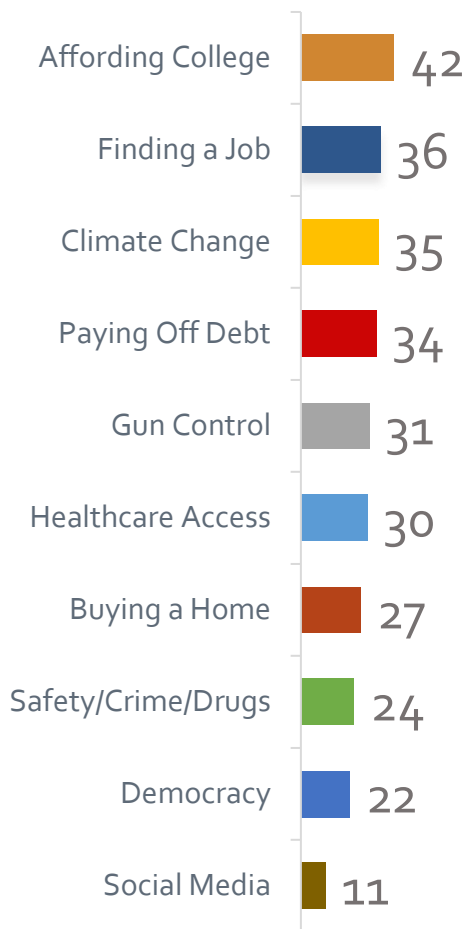
